This recognition rewards the Group journey toward transparency and concrete action on sustainability, confirming the importance of ESG reporting as a strategic lever to strengthen resilience and competitiveness.

In 2024, Esprinet took significant steps to consolidate its role as a responsible entity in the ICT and Green Tech market. The company has invested in energy efficiency and reducing its environmental footprint. The new logistics hub in Tortona, LEED® Gold certified, has been equipped with photovoltaic and LED lighting systems to move closer to energy self-sufficiency, following the example of the Cambiagio (MI) warehouse, which is already 100 percent self-sufficient.

On the innovation side, the establishment of Zeliotech, a wholly owned subsidiary of Esprinet Group, has consolidated the group as Europe's leading distributor of enabling technologies for a more sustainable future, representing a decisive step in the Double Transition, digital and green.

In 2024, the company, strengthened ESG governance too. In particular, with the launch of the first CSRD-compliant reporting, it promoted a more structured internal dialogue between departments and the Competitiveness and Sustainability Committee to ensure transparency and responsible management. In addition, it has enhanced employee training and listening programs, fostering a culture of diversity, equity and inclusion, with a focus on intergenerational dynamics.

As further confirmation of this commitment, Esprinet has joined the United Nations Global Compact, the world's largest corporate sustainability initiative, taking responsibility for implementing the Ten Principles on human rights, labor standards, environment and anti-corruption.

The score awarded by CDP highlights the importance of transparency and strategic management of environmental issues. Data provided by Esprinet will be shared with investors, customers, and stakeholders to support ESG-based decisions, facilitating regulatory compliance and climate risk monitoring.
